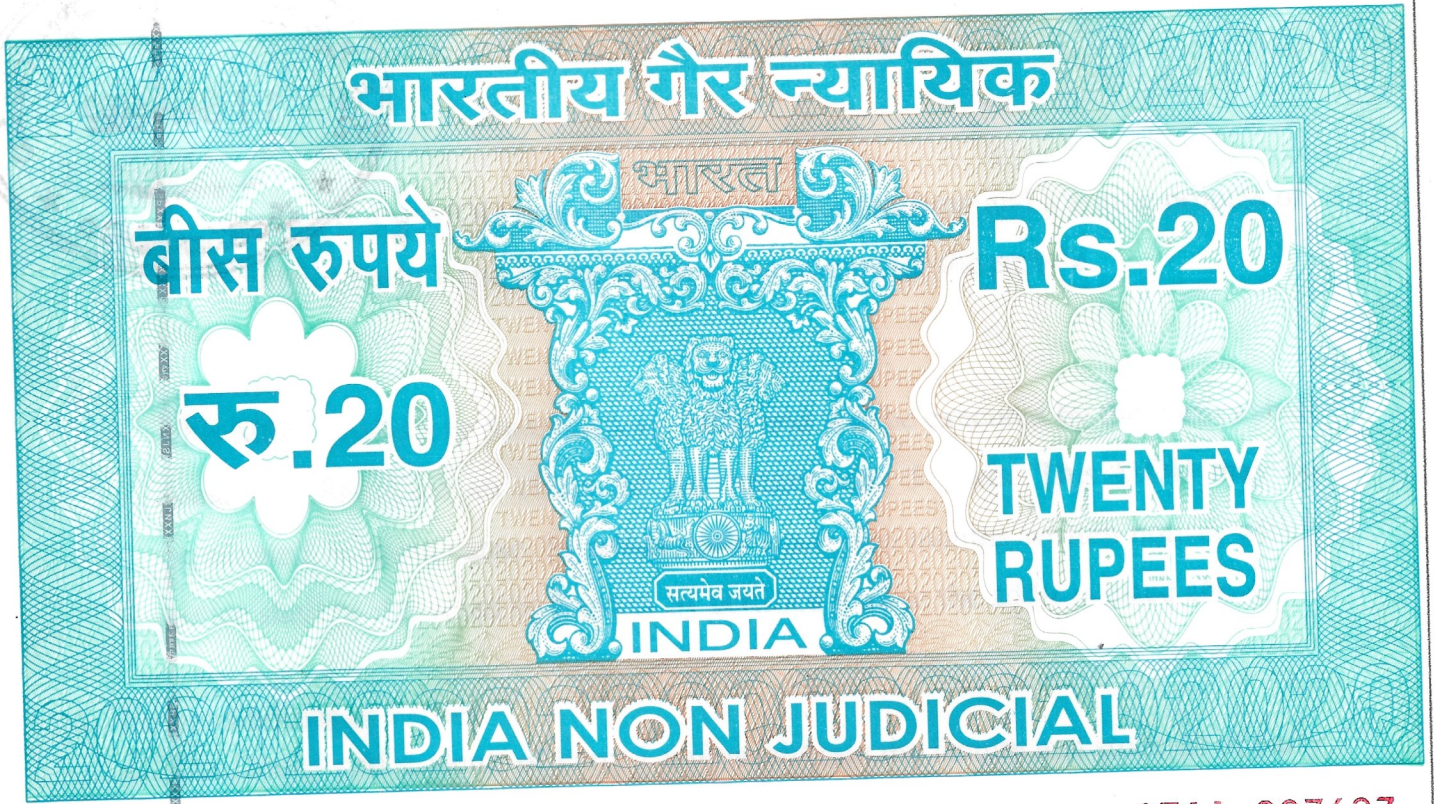

1. Parties:

2. Purpose:

3. Term of MOU:

- This MOU is effective from January, 2022 and will be executed by the parties shall remain in full force an effect for not longer than 5 years. This MOU may be terminated, without cause, by either party upon two months written notice, which notice shall be delivered by hand or by certified mail to the address listed above.

- Mere participation of faculty and students of Party 1 in teaching the faculty and students of Party 2 according to this MOU does not carry any right or any legal entitlement of demand for placement with Party 2.
- The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties.

The effective date of this MOU is the date of the signature last affixed to this page.

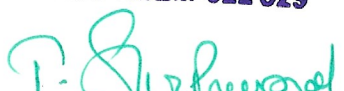

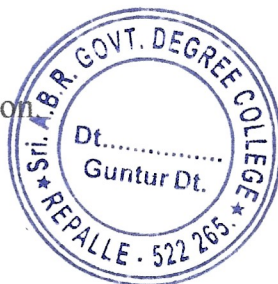
