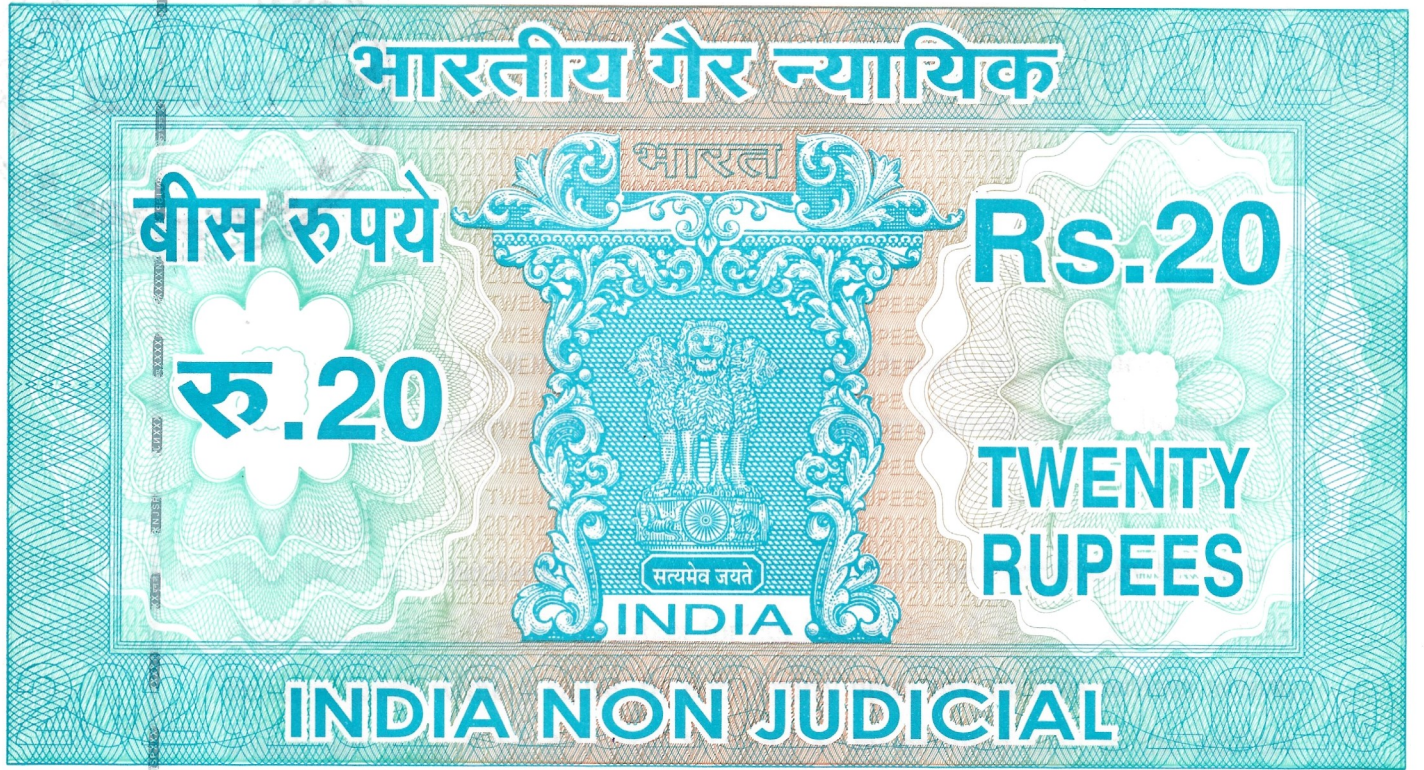

- The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties.
