THE MAIN OBJECTIVES OF THIS PROGRAM ARE AS FOLLOWS:

- > To educate students on the dehumanizing effects of ragging and it's perversity.
- > To keep a consent eye and vigil on ragging in order tom prevent it's occurrence and reoccurrence.
- > Deal with ragging incidents that come to our attention in a timely and stringent manner.
- > To create a disciplined environment by sending a clear message that act of ragging will be tolerated and that any act of Ragging will not go unnoticed and unpunished.
- > To inform students about the punishments that will be imposed on students who are found guilty of ragging.

BRIEF REPORT:-

- Anti Ragging committee of our institution arranged an anti-ragging awareness session on August, 2019, in the seminar hall of the college. Dr. T. Siva Prasad blessed the occasion with his opening remarks. Sri. S.Uma Rani, Mahila Police, Pothnakatlavani Palem Sachivalayam gave an extensive talk on ragging sensitizing students on regulations of the act.
- As per the Supreme Court judgement on ragging in the Colleges, the following actions will be taken
 on those students who indulge in ragging Withholding of scholarships, fellowships & results.
- Debarring from representing in events and appearing for tests/examinations and also consequent admission to any other institution.
- Withdrawing benefits like travel concessions and campus selections.
- Suspension or expulsion from hostel or mess and also attending classes.
- Cancellation of admission or rustication from the Institution.
- Registration of FIR against the accused and Prosecution under the Indian Penal Code, 1860.
